associated with Wife's vehicles including, but not limited to gas, oil, automobile insurance, taxes, title, repairs and maintenance, and she shall indemnify, defend, and hold Husband harmless for the payment of same. Husband shall cooperate with Wife to transfer title and registration of her vehicle within thirty (30) days of this agreement.

## 6. MARITAL INDEBTEDNESS

- A. Joint Debts: The parties acknowledge that they have incurred joint marital debt during the course of their marriage, which is detailed in Exhibit A of this Agreement. The Husband agrees to take full responsibility for the repayment of the joint marital debt. To satisfy this obligation, the Husband shall use his portion of the proceeds from the sale of the marital residence, as outlined in the Settlement Agreement regarding the sale of the home. The Husband shall be solely responsible for ensuring that all joint debts are paid in full, and he agrees to indemnify and hold the Wife harmless from any future liability related to these debts. The Wife shall have no further obligation to contribute to the repayment of any joint marital debt after the sale of the marital residence, and upon the Husband's satisfaction of this debt obligation, both parties will be released from any further financial responsibility related to such debts. The Husband will provide the Wife with documentation proving that the joint debts have been fully paid from the proceeds of the sale.
- B. Husband's Debts: Husband shall be responsible for any and all debts in his individual name including but not limited to personal loans, business loans, loans against retirement accounts, state and Federal tax debts, liens, car loans, judgments, credit cards, and student loans. Husband shall pay and hold Wife harmless from any claims, debts, liabilities, and obligations of any nature whatsoever, contingent or otherwise, which Husband has incurred individually or jointly with any third person, persons, or other entities. Husband promises to defend Wife against any attempts by any of his creditors to collect the same from Wife, and further promises to indemnify Wife fully from any liability and expenses, including legal expenses, which may result from his obligations. In the event that any creditor of Husband obtains or attempts to obtain a lien against any real or personal property in which Wife has an interest, Husband shall promptly undertake to satisfy the obligation giving rise to the lien and shall indemnify, defend, and hold Wife harmless against any actions taken by such creditors.
- C. Wife's Debts: Wife shall be responsible for any debts in her individual name including but not limited to personal loans, business loans, loans against retirement accounts, state and Federal tax debts, liens, car loans, judgments, credit cards, and student loans. Wife shall pay and hold Husband harmless from any claims, debts, liabilities, and obligations of any nature whatsoever, contingent or otherwise, which Wife has incurred individually or jointly with any third person, persons, or other entities. Wife promises to defend Husband against any attempts by any of her creditors to collect the same from Husband and further promises to indemnify Husband fully from any liability and expenses, including legal expenses, which may result from her obligations. In the event that any creditor of Wife obtains or attempts to obtain a lien against any real or personal property in which Husband has an interest, Wife shall promptly undertake to satisfy the obligation giving rise to the lien and shall indemnify, defend, and hold Husband harmless against any actions taken by such creditors.
- D. <u>Subsequent Debts.</u> Except as otherwise set out in this Agreement, Husband and Wife shall not at any time hereafter contract any debts, obligations or other liabilities whatsoever for which the other or his or her property or estate shall become or may become liable or answerable.

## 10. TAX MATTERS

- A. The parties shall file separately for the year 2025 and all subsequent years and shall each be solely responsible for any tax, penalties and all other liabilities whatsoever regarding his or her respective incomes, including the parties' respective W-2, 1099 and K-1 income, and each party shall indemnify, defend, and hold the other harmless from and against same, including payment of the other's attorney's fees and costs of litigation should the issue be litigated. The parties agree that Wife shall claim the minor children as dependents on her taxes.
- **B.** Each party shall be solely responsible for and shall pay any and all assessments of income taxes, interest or penalties imposed by any state or federal government in regard to the filing of the parties joint income tax returns to the extent
