MEMORANDUM OF UNDERSTANDING

The parties attended mediation on December 2, 2022. Plaintiff appeared Pro Se and Defendant was represented by Counsel. The parties agree to be bound by the following terms, which reflects their *full and final agreement*:

I. RESIDENCES

Wife shall have exclusive use, possession, and ownership of her current home located at 6207 Britt Road, SW, Mableton, Georgia.

Husband shall have exclusive use, possession and ownership of his current home located at 1047 Strawberry Lane, Ellenwood, Georgia.

Both parties shall be solely responsible for any and all expenses affiliated with their respective residences and indemnify the other party against collection of the same.

II. PENSION

Wife shall be entitled to one-half (1/2) of the marital portion of Husband's UPS (possibly housed under T-Force Freight) pension. This shall be calculated as the portion of the pension that accrued from the date of marriage until the date that the Final Divorce Decree is entered. The parties shall equally split the cost of the QDRO. Husband shall fully cooperate with Wife and provide any additional documentation needed to effectuate the QDRO. Wife shall be responsible for coordinating the QDRO with the Law Office of Matthew Lundy. Husband shall select Surviving Spouse Benefits (SSB) if applicable so that Wife can continue to receive her portion of the pension upon Husband's death.

III. FINANCIAL ACCOUNTS

Husband shall have sole claim to his 401(k) with UPS.

Each party shall have sole claim and access to any financial account (including checking, savings, investment accounts, etc.) that are not expressly mentioned herein.

IV. DEBTS

The parties do not have any joint debts. Each party is to be solely responsible for his/her individual debts and shall indemnify the other party against collection of the same.

V. ALIMONY

Husband shall pay Wife alimony in the amount of \$600 per month for a period of twenty-four (24) months commencing on January 1, 2023 and continuing on the first day of each month thereafter. Wife shall be paid via an Income Withholding Order. Husband shall pay Wife directly via Zelle until the IWO takes effect.

VI. FURNISHINGS

Wife shall retain all furnishings in the Martial Residence with the exception of the Husband's personal effects. Husband shall retrieve his personal items from the home no later than sixty (60) days.

VII. ATTORNEY'S FEES

Husband shall reimburse Wife the sum \$500.00 in attorney's fees. Husband shall remit the payment to Wife no later than January 16, 2023 via Zelle.

VIII. NON-INTERFERENCE

Neither party shall harass the other party or disparage the other party in the community or on social media. Neither party shall request that third parties harass the other party.

IX. MAIDEN NAME RESTORED

Defendant's maiden name shall be restored.

X. VEHICLES


Each party shall have sole ownership of his/her respective vehicles. Each party shall be solely responsible for any debts or costs affiliated with his/her individual vehicle.

XI. HEALTH INSURANCE


Each party shall be responsible for his/her individual health insurance upon entry of the *Final Divorce Decree*.
