**MEDIATED MARITAL SETTLEMENT AGREEMENT**


The parties agreed to attend mediation in a virtual setting. The parties exchanged financial affidavits prior attending this mediation, and neither requires any additional discovery.


The parties are both unrepresented. The parties have each been advised that they have the right to take this Mediated Marital Settlement Agreement to an attorney of his or her own choosing for review prior to executing same. Each party declines that opportunity and wishes to proceed as written.

The parties stipulate and agree as follows:

1. The Wife shall be entitled to sole ownership, use and possession of the 2015 Hyundai Santa Fe. She shall indemnify and hold harmless the Husband from all liability thereon.
2. The Husband shall be entitled to sole ownership, use and possession of the 2018 Kia Forte. He shall indemnify and hold harmless the Wife from all liability thereon.
3. LIABILITIES:

The Wife shall be solely responsible for the :



The Husband shall be solely responsible for the:



- a. Loan for the Kia Forte- Balance- \$15,833.00
  - b. Credit One – Balance- \$272.00
  - c. All medical bills for his care and treatment
  - d. Net Credit- Balance- \$900.00
  - e. American – Balance – \$700.00
  - f. Money Lion – Balance - \$725.00
4. ASSETS: The parties agree to each keep any and all bank accounts, brokerage accounts, savings accounts, and similar in his or her name. There are no joint accounts.
  5. Personal Property: The parties will likely continue to cohabitate for a period of time after the entry of Final Judgement. The parties will equally divide all of the personal property in the marital residence. However, if an item is in dispute, the parties shall return to mediation to determine ownership of the personal property.
  6. Both parties waive alimony in any and all forms whatsoever.
  7. Each party shall be responsible for his or her own attorneys fee's and costs.
  8. The parties have roughly equal timesharing with the children. The Father's income was lower this year due to an illness but the Father is now working full time again

and agrees to have income imputed at the rate of \$52,000.00 per year. The child support guidelines show Mother should pay Father \$20.25 per month, but the parties do not wish to have child support paid since it is de minimis. Therefore, neither shall pay the other support.

9. The parties shall equally split the costs for all mutually agreed extracurricular activities, mutually agreed summer camps, employment related after school care or daycare, all medical, dental, vision, prescription, orthodontic, counseling, psychiatric, physical therapy, and similar uncovered expenses for the children.
10. The Father shall maintain health, dental, and vision coverage for the children so long as it is reasonably available through his employer.
11. Both parties shall timely and properly execute any and all documents necessary to effectuate this Mediated Marital Settlement Agreement.
12. The Wife has a 401k with both marital and premarital components, as a result of her employment with Seacoast Bank. The Husband is entitled to  $\frac{1}{2}$  of the marital portion, together with gains or losses, MINUS \$549.86. This shall be accomplished via QDRO to be prepared by Matt Lundy, 10101 W Sample Rd., Coral Springs, Florida 33065-3907. 855-737-6529. [info@mattlundylaw.com](mailto:info@mattlundylaw.com). Each party shall pay  $\frac{1}{2}$  of Attorney Lundy's fees to obtain the QDRO.



13. The Husband has a 401k valued at approximately \$1,099.72. The Wife's portion of this is subtracted above in the QDRO calculation. Therefore, the Husband is entitled to sole ownership, use and possession of his 401k account.
