AFFIDAVIT OF GRETCHEN SHIRLEY

PERSONALLY APPEARED before the undersigned officer duly authorized by law to administer oaths, Gretchen Shirley, who, after first being duly sworn, deposes and states as follows:

1)

My name is Gretchen Shirley, and I am the Petitioner in the above-styled action. I am over the age of twenty-one (21) years, and I am competent to make this *Affidavit*.

2)

I make the statements contained in this *Affidavit* from personal knowledge.

The purpose of this *Affidavit* is to be used in order for me, as Petitioner, to obtain a *Final Judgment and Decree of Divorce*, based upon my *Complaint for Divorce and Other Relief* (hereinafter "Complaint"), without the necessity of the hearing in the above-styled action.

The parties have been living in a bona fide state of separation since I filed this divorce action.

There are no minor children as a result of this marriage, and none are expected.

9)

I entered into a *Settlement Agreement* with the Respondent, resolving all issues in the above-styled action, and said *Settlement Agreement* has been filed with the Clerk of the Superior Court of Fulton County. I am asking that said *Settlement Agreement* be incorporated into the *Final Judgment and Decree of Divorce*.

All allegations in my *Complaint* are true and correct, and I hereby reaffirm all those allegations.
