22 **DECREE OF DIVORCE**

23 This cause having come on for Case Management Conference on November
24 2, 2022, Defendant GEORGE MARTIN CORCORAN being present with his
25 attorney of record, REBECCA BLAIR, ESQ., of the Law Firm of GALLARDO &
26 ASSOCIATES LLC, the Court being advised in the premises, and the same having
27 been submitted to the above-entitled Court for decision pursuant to Chapter 125 of
28 the Nevada Revised Statutes, and the Court having reviewed the pleadings and

1 filings herein, and that the requirements of Chapter 125.181 have been met; that
2 Plaintiff has resided in the State of Nevada for the required six (6) weeks prior to
3 filing of this action; the Court finds that it has complete jurisdiction as to the subject
4 matter and personal jurisdiction, and all other relevant provisions of Chapter 125.181
5 of the Nevada Revised Statutes.

8 THE COURT HEREBY FINDS that, for more than six (6) weeks immediately
9 preceding the commencement of this action, Plaintiff has been and is now a bona
10 fide and actual resident and domiciliary of the State of Nevada, County of Clark, and
11 has been actually and corporeally present in said State and County for more than six
12 (6) weeks prior to the commencement of this action; that the Court has complete
13 jurisdiction as to the subject matter and personal jurisdiction, and all other relevant
14 provisions of Chapter 125.181 of the Nevada Revised Statutes have been met.

18 THE COURT FURTHER FINDS that Plaintiff and Defendant were married
19 on March 31, 2018, in New Orleans, Louisiana.
20

21 THE COURT FURTHER FINDS that the parties are incompatible in
22 marriage and are therefore entitled to an absolute DECREE OF DIVORCE.
23

24 THE COURT FURTHER FINDS that there are no minor children born the
25 issue of the parties or adopted by the parties and, to Defendant's knowledge,
26 Plaintiff is not now pregnant.
27

28 THE COURT FURTHER FINDS that there is a piece of community

1 property in the form of the marital residence located at 3458 Monte Carlo Drive,
2 Las Vegas, Nevada 89121, and that the parties are presently in the process of
3 selling said marital residence.
4

5 **NOW THEREFORE, IT IS ORDERED** that the Bonds of Matrimony
6 now and heretofore existing between the Plaintiff and the Defendant be, and the
7 same are hereby dissolved, and set aside and held for naught, and the parties are
8 absolutely divorced and released from any marital obligations to each other, and
9 that each of the parties hereto is hereby restored to the status of a single, unmarried
10 person.
11

12 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that
13 neither party will pay spousal support to the other and this provision is non-
14 modifiable.
15

16 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the
17 marital residence located at 3458 Monte Carlo Drive, Las Vegas, Nevada 89121,
18 shall be sold and the proceeds of the sale shall be equally divided among both
19 parties.
20

21 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that, in
22 the event that there exists any lis pendens regarding the real property located at
23 3458 Monte Carlo Drive, Las Vegas, Nevada 89121, such lis pendens shall be
24 removed and shall not inhibit the sale of the real property located at 3458 Monte

2 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the
3 following property is confirmed as the sole and separate property of Plaintiff,
4
5 DAWN MARIE FISHER-CORCORAN:

- 6 a. Any and all bank accounts in Plaintiff DAWN MARIE FISHER-
7
8 CORCORAN's name;
- 9 b. Any and all retirement accounts in Plaintiff DAWN MARIE FISHER-

11 CORCORAN's name; and
- 12 c. Any and all personal property currently in Plaintiff DAWN MARIE
13
14 FISHER-CORCORAN's name and/or possession.

15 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the
16 following property is confirmed as the sole and separate property of Defendant,
17
18 GEORGE MARTIN CORCORAN:

- 19 d. Any and all bank accounts in Defendant GEORGE MARTIN
20
21 CORCORAN's name;
- 22 e. Any and all retirement accounts in Defendant GEORGE MARTIN
23
24 CORCORAN's name; and
- 25 f. Any and all personal property currently in Defendant GEORGE
26
27 MARTIN CORCORAN's name and/ or possession.

28 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the

1 parties will each be responsible for their respective attorney fees.

2 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that all
3 future hearing dates be vacated.


4 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that
