SECOND AMENDED FINAL JUDGMENT AND DECREE

In the event of any conflict, the terms of the Child Support Addendum shall control.

EQUITABLE DIVISION

The parties have entered into a comprehensive Settlement Agreement which divides all the marital assets. Said Settlement Agreement is incorporated herein and made part of this Order. The Settlement Agreement incorporates all issues of distribution and division of marital assets.
