FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

This cause came before this Court for a hearing on the parties' Petition for Dissolution of Marriage. The Court, having reviewed the file and heard the testimony, makes these findings of fact, and reaches these conclusions of law:

1. The Court has jurisdiction over the subject matter and the parties.
2. At least one (1) party has been a resident of the State of Florida for more than six (6) months immediately before filing the Petition for Dissolution of Marriage.
3. The parties have no minor or dependent children in common, no children born to either spouse during the marriage remain minor or dependent and the Wife is not pregnant.
4. The marriage between the parties is irretrievably broken.
5. The parties entered into a Marital Settlement Agreement dated August 30, 2021.
6. The Marital Settlement Agreement, dated August 30, 2021, is hereby ratified, approved incorporated by reference into Final Judgment, as if fully set forth herein. Both parties are ordered to comply with all the terms and provisions of the Agreement.
7. The Court finds that the Marital Settlement Agreement was entered into freely and voluntarily, with no coercion or duress placed on either party to execute the Agreement, is fair and equitable.

It is ORDERED and ADJUDGED that:

- A. The parties' marriage is hereby dissolved.
- B. The Court retains jurisdiction over the subject matter and the parties hereto for the purpose of enforcing the provisions of the Marital Settlement Agreement, dated August 30, 2021, the Final Judgment or any other Order to effectuate the parties' agreement.
- C. The Court reserves jurisdiction to enforce this judgment.
