**FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE**

THIS CAUSE came on for Uncontested Final Hearing on July 13, 2022 on Wife's Petition for Dissolution of Marriage and Other Relief, filed November 19, 2021, and Husband's Answer to Wife's Petition for Dissolution of Marriage and Counterpetition, filed December 17, 2021, and the Court having considered the contents of the Court file, the evidence presented, the parties' Marital Settlement Agreement dated June 8, 2022 and Parenting Plan dated June 8, 2022, and being otherwise fully advised in the premises, it is

ADJUDGED:

1. This Court has jurisdiction over the subject matter and the parties.
2. The parties have been residents of the State of Florida for more than six months immediately before filing the Dissolution of Marriage.
3. The parties were married to each other on August 25, 2012.
4. The parties have two children born of the marriage, L.C.P., born in 2011 and G.J.P., born in 2015. The Wife is not pregnant.
5. The parties' marriage is irretrievably broken. The marriage between the parties is dissolved.
6. The Marital Settlement Agreement and Parenting Plan executed by the parties on June 8,

2022 are approved and adopted by the Court and the parties are ordered to comply with the terms of the Marital Settlement Agreement and Parenting Plan. The Marital Settlement Agreement and Parenting Plan shall not merge into the Final Judgment.

7. The Court reserves jurisdiction to enforce and modify this Final Judgment of Dissolution of Marriage, Marital Settlement Agreement and the Parenting Plan.
