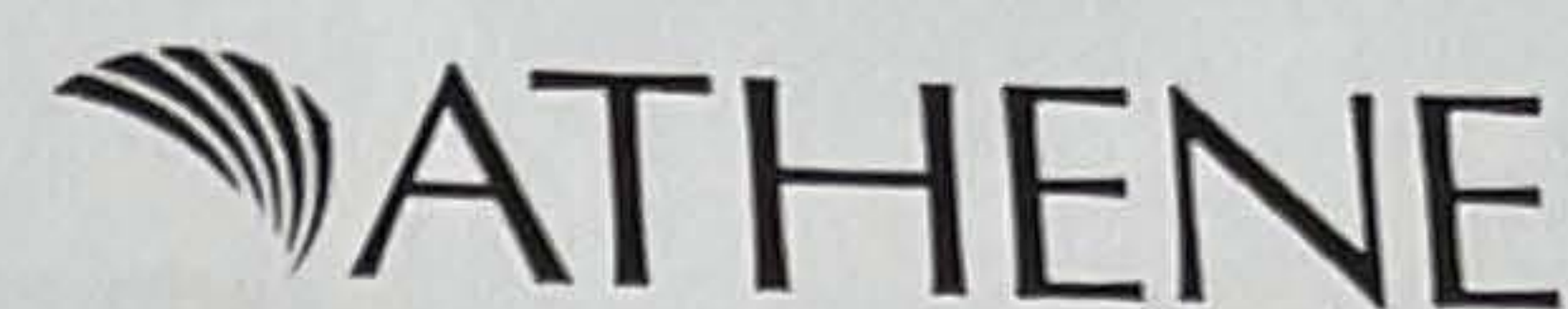

QUALIFIED DOMESTIC RELATIONS ORDER

WHEREAS, the parties were married on _____ and divorced on

_____.

WHEREAS, this Order is intended by the parties and the Court to constitute a Qualified Domestic Relations Order pursuant to Section 401(a)(13) and Section 414(p) of the Internal Revenue Code of 1986 as presently amended and in effect (“Code”) and Section 206(d) of the Employees Retirement Income Security Act of 1974 as amended and in effect (“ERISA”); and

NOW, THEREFORE, pursuant to this state’s Domestic Relations Laws, IT IS HEREBY ORDERED BY THE COURT as follows:

1. **PLAN:** This Order shall be applicable to the _____ Plan (the “Plan”) together with any successors or assigns. The obligation for the payment of the Participant’s benefits under the Plan was transferred to a Group Annuity Contract with Athene Annuity and Life Company (“GAC Administrator”).
2. **PARTICIPANT:** _____ (“Participant”) is a Participant in the Plan whose last known or current address is _____. The Participant’s social security number and date of birth are included on the attached addendum to this Order.
3. **ALTERNATE PAYEE:** _____ (“Alternate Payee”) is the former spouse of the Participant and is hereby designated Alternate Payee of a portion of Participant’s accrued benefit in the Plan. Alternate Payee’s last known or current address is _____. Alternate Payee’s social security number and date of birth are included on the attached addendum to this Order.

4. **PAYMENT TO ALTERNATE PAYEE:** This Order awards and assigns to Alternate Payee a shared interest in Participant's vested accrued benefit in an amount equal to _____ Percent (___%) of the Participant's prospective benefit payments from the Plan.
5. **PAYMENT FORM/COMMENCEMENT:** The Alternate Payee's benefit shall be paid to the Alternate Payee in accordance with the payment method selected by the Participant at the time of his or her benefit commencement. The Alternate Payee may not elect a form of benefit payment for his or her shared interest award. The Alternate Payee's benefit shall commence as soon as administratively feasible following qualification of the order and will be effective as of the first of the month following the date on which the order was received and approved (and will take prospective effect).
6. **DEATH OF ALTERNATE PAYEE:** If Alternate Payee dies prior to or subsequent to the commencement of the awarded benefit, the benefit shall revert to the Participant. Alternate Payee may not name a beneficiary.
7. **DEATH OF PARTICIPANT:** If Participant dies prior to or subsequent to the commencement of the awarded benefit, the benefits to Alternate Payee hereunder shall cease. Alternate Payee shall receive his or her survivor benefit under the Participant's previously elected form of payment as beneficiary, only if Alternate Payee was named beneficiary in accordance with Participant's form of payment upon commencement of benefits.
8. **STATEMENT OF PURPOSE:** This Order is intended by the parties and the Court to constitute a Qualified Domestic Relations Order pursuant to Code Sections 401(a)(13) and 414(p) and ERISA Section 206(d) and effect the distribution and assignment of a portion of the Participant's accrued benefit under the Plan. This Order is not intended, and shall not be construed in such a manner as to require the Plan or GAC Administrator: (a) to provide any type or form of benefit option not otherwise provided under the terms of the Plan; (b) to require the Plan to provide increased benefits determined on the basis of actuarial value; or (c) to require the payment of any benefits to the Alternate Payee that are required to be paid to another alternate payee under another order that was previously deemed to be a QDRO. In the case of a conflict between the terms of this Order and the terms of the Plan, the terms of the Plan shall prevail.
9. **FURTHER ACTION BY PARTIES:** The Parties shall be required to take such further action as may be necessary to both ensure that prompt determination is made by the GAC Administrator that this Order constitutes a Qualified Domestic Relations Order and complete such forms or documents as may be required by the Plan to facilitate the transfer of accrued benefit as ordered herein.
10. **RETAINED JURISDICTION:** The Court retains jurisdiction to enforce, revise, modify or amend this Order insofar as necessary to establish or maintain its qualification as a QDRO or to amend this Order for other reasons, provided, however, neither this Order nor any subsequent revision, modification, or amendment shall require the Plans to provide any benefit not otherwise provided by the Plan.
